Apprentice Membership Admission Procedures

All applicants for apprentice membership to the Sheboygan Yacht Club shall be sponsored by at least two Active or Active Life members in good standing. The procedure for admission to membership shall be as follows:

1. **Application:** A “prospective member information and application form” shall be obtained from the Membership Secretary, completed by the applicant and sponsors, and returned to the Membership Secretary prior to any regularly scheduled board meeting.
2. **Board Appearance:** Initially, at a board meeting, the sponsors shall appear to discuss the application. At the same meeting, the board may interview the applicant with his or her sponsors.
3. **Posting:** Following the board appearance of the sponsors and applicant, the name of the applicant shall be posted on the bulletin board until the next regularly scheduled board meeting and shall appear in the next issue of the club newsletter.
4. **Vote on Membership:** The vote of the board on the acceptance of an Apprentice member shall be held at the next regularly scheduled board meeting following the board appearance of the applicant and sponsors, and posting. Acceptance shall be by majority vote of the board.
5. **Induction:** An accepted applicant shall be inducted as an Apprentice member at the next regularly scheduled membership meeting.
